STRATEGIC AND THEMATIC OBJECTIVES

The Programme has **three strategic objectives**:

A - Promotion of economic and social development in regions on both sides of the common borders;

B - Addressing common challenges in environment, public health, safety and security;

C - Promotion of better conditions and modalities for mobility of persons, goods and capital.

Strategic objectives are supported by **four thematic objectives** (TO):

TO1 - Business and SME development

TO5 - Support to local and regional good governance

TO6 - Environmental protection, climate change mitigation and adaptation

TO10 - Promotion of border management and border security, mobility and migration management

For the 1st Call for proposals thematic objectives TO1, TO5 and TO6 are opened.

DURATION OF THE PROJECTS

The maximum project duration is 24 months for projects not exceeding 200 000 EUR and up to 36 months for projects exceeding 200 000 EUR.

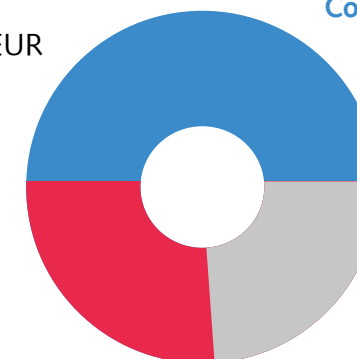
Large Infrastructure Projects (LIPs) are strategic cross-border investment projects identified by the Programme and are contracted through the direct award procedure.

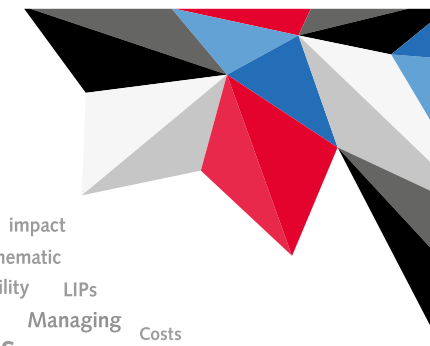


