Summary of the Project

Common Peipsi 2 project will contribute to improvement of the environmental situation of the Lake Peipsi/Chudsko-Pskovskoe basin and development of local tourism economy. Thus border area will become more attractive for investments, businesses, inhabitants and visitors.

Reconstruction of waste-water facilities in Russia and establishing contemporary infrastructure in small harbours on Estonian and Russian sides are foreseen by the project:

In Russia:

- Reconstruction of 1 water (in Cheryokha village) and 1 wastewater treatment facility (in Pskov city);
- Construction of the contemporary mooring infrastructure in Tolbitsa village of Pskovsky area in accordance to environmental requirements;
- Purchase of passenger vessel for regulating transport connection in the Pskov-Peipsi water area between mainland and islands in Pskovsky area for local inhabitants, entrepreneurs and tourists.

In Estonia:

- Construction of 3 small harbours (in Värskä, Luunja, Vasknarva of Alaguse) and establishment of new contemporary infrastructure in these small harbours (stationary and floating piers, slips, facility for disposal of garbage, lighting, toilet, crane platform, etc);
- Further development of small harbours in Mustvee and Räpina: services, repair halls, water and wastewater facilities, places for yacht landing, recreation area, etc; construction of hall for historic passenger ships in Tartu as educational-cultural centre;
- Establishment of new workplaces in small harbours.
