## SUMMARY OF THE PROJECT

---

Integrated construction and improvement of the historical promenade areas in Narva/Estonia and Ivangorod/Russia and conversion of the CBC area into attractive place for tourism and business development

The project is the logical continuation of the project “Development of historical riverside protection area in Narva/Estonia and Ivangorod/Russia II stage” implemented within the framework of Estonia-Latvia-Russia CBC Programme 2007-2013.

During its implementation reconstruction of promenades will be continued: in Ivangorod – from northern part of promenade to bridge “Friendship”, in Narva - the promenade part in Joaorg recreation area.

The number of works is planned for the improvement of tourism infrastructure:

On Estonian side:

- Shore reinforcement 2460 m<sup>2</sup>, construction of footpath 3300 m<sup>2</sup>, footpath and bike lanes length ca 850 m, roads ca 1110 m<sup>2</sup> reconstruction.
- Construction of footpath 591 m<sup>2</sup>, plats 372 m<sup>2</sup>, fences ca 27 m, roads ca 739 m<sup>2</sup> reconstruction, parking (10 cars and 1 bus places), 1 stairs construction.

On Russian side:

- Shore reinforcement, construction of footpath, bike lanes length ca 500 m and width ca 1, 5 m, installation of sustainable LED lighting, construction of the pier, construction of 4 stairs and fences about 600 m long.
- Pontoon (length ca 15 m), toilet, open stage (scene) with seat places (about 200 seats), video surveillance system with at least 2 video cameras, playground (about 540 m<sup>2</sup>) and outdoor fitness equipment, 1 info-board installed.
